ACUNS, built on the premise that solutions to improve the human condition are more likely to advance through scholarly assessment, broad-based deliberations, international covenants and multilateral action, is a global professional association that brings together people and institutions active in the work and study of the United Nations. ACUNS promotes dialogue, scholarship, teaching, and mutual understanding among academics, policymakers, UN staff, diplomats, civil society, entrepreneurs, teachers and students.

MAJOR ACTIVITIES

- The ACUNS Annual Meeting. Held since 1988 in cities around the world, it attracts prominent scholars and practitioners. Key features include the John W. Holmes Lecture, the Lecture in Honour of Kofi Annan, and awards for best doctoral Dissertation and Book on UN subjects.
- Global Governance: A Review of Multilateralism and International Organizations, our peer-reviewed journal showcases essential scholarly research on the United Nations System and multilateral topics.
- The ACUNS-UN Workshop, held annually in partnership with the United Nations Secretariat's Office of Human Resources, fosters dialogue and exchange of ideas as well as experience between UN staff and academics.
- The Monthly Bulletin, emailed to our 4,700-strong global network, features ACUNS news, updates on events, publications and opportunities.

2 Liaison Offices

4 The Global Innovation Governance Network

The Global Governance Innovation Network amplifies the voices of a new generation of scholars, policy researchers, and practitioners from the Global South and North, alongside seasoned veterans and Permanent Representatives to the United Nations. The network's core activities include policy- oriented briefs and reports, an online community of practice, and (in-person and virtual) global and regional policy dialogues.
